



## NEBOSH Certificate in Environmental Management (EC1)

### Who can benefit from this course?

People throughout the world who understand the growing importance of holding a recognised and respected environmental management qualification.

Topics help line managers, HSE managers, supervisors and HR practitioners to strengthen the understanding in the areas of Environmental Management Systems (ISO14001) and Impact Assessments, energy efficiency, control of pollution, planning for and dealing with environmental emergencies.

Achieving your NEBOSH certificate in environmental management means that you have fulfilled the requirements for IEMA Associate level membership (AIEMA) as long as you apply within three years of achieving your certificate.

The Certificate is also accepted by the Chartered Institution of Water and Environmental Management (CIWEM) to meet the requirements for technician membership (Tech CIWEM)

It also meets the requirements for Associate Membership of the International Institute of Risk and Safety Management (AIIRSM).

### Pre-course requirements

No formal previous health and safety knowledge is required. Anybody who needs a basic understanding of environmental issues in the workplace.

English language skill level 6 or higher in IELTS, or equivalent is recommended, but not mandatory, for those whom the first language is not English.

### Course Content

1. Foundations in environmental management
2. Environmental management systems
3. Environmental impact assessments
4. Controls of emissions to air
5. Control of contamination of water resources
6. Control of waste and land use
7. Sources and use of energy and energy efficiency
8. Control of environmental noise
9. Planning for and dealing with environmental emergencies

### Assessment

- Unit EC1 is a taught unit, assessed by one two-hour written examination
- The written examination consists of ten 'short-answer' questions (8 marks each) and one 'long-answer' question (20 marks)
- All questions are compulsory
- Candidate scripts are marked by external examiners appointed by NEBOSH
- Unit EC2 is assessed by a practical examination carried out in the candidates own workplace

### Certification

NEBOSH will issue certificate for those who successfully completed the course and passing the examination.
